### **Notes:**

- 1.** Once item has been inspected to ensure no prohibited items are concealed therein. Items must be x-rayed when asses is available
- 2.** Transported in an enclosed container (hard-case recommended for liability reasons) however, soft case is allowed. Must be stowed in an inaccessible compartment. Items may not be allowed due to operational impact on revenue freight. (Space available only)
- 3.** Mechanics or other employees who are jumpseating needing to bring their tools and the items are found to be on the Prohibited Items List must get approval from the Flight Captain to bring the items onboard the aircraft. If the Flight Captain approves, the items must either be secured in the belly of the aircraft or secured in the cockpit with the crew.
- 4.** Exceptions can be granted through Aviation Security and must be requested 48 hours prior to Jumpseating. Jumpseater must carry the approved security letter with them and the items must be stowed in the belly of the aircraft, if approved, and the flight crew must be made aware of the exception.
- 5.** FFDO's are allowed to carry Transportation Security Administration (TSA) approved restraining devices.
- 6.** Alcoholic beverages, when in unopened retail packing, containing more than 24% but not more than 70% alcohol by volume when in receptacles not exceeding 5 liters (1.3 gallons) carried in carry-on or checked baggage, with a total net quantity per person of 5 liters (1.3) gallons for such beverage. All alcohol containers must be sealed and kept sealed while jumpseating and on FedEx property.
